Privacy notice

Budapest Capital VIII. district Józsefváros Municipality on data management related to registration for events

The Municipality of Józsefváros District VIII of Budapest (hereinafter: Municipality) and the Mayor's Office of Józsefváros District VIII of Budapest (hereinafter: Mayor's Office) (hereinafter jointly: Joint Data Controllers) organise events (hereinafter: Events). The Joint Controllers may take photographs and videos at the events, in which case the most illustrative photographs and videos of the event will be published on the Joint Controllers' website, Facebook and Instagram pages, occasionally in the district newspaper or on other media surfaces of the Municipality of Budapest Capital VIII.

The information notice on data processing in connection with registration for events (hereafter referred to as the 'Data Processing Notice') is based on the Directive of the European Parliament and of the Council of 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC. Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data (hereinafter referred to as the General Data Protection Regulation) and contains the rules on the processing of personal data, the data processing rights of the natural persons or organisations registering for the event, the contact person submitting the event (hereinafter collectively referred to as the data subject) and the data subject's legal remedies.

If the event includes the taking of images or audio recordings, the Joint Controllers will seek the explicit consent of the data subjects to the taking and publication of the image during the registration process for the event. If a data subject does not wish to be included in the recordings, the Joint Controllers shall provide the data subjects with the possibility to be in a recording-free zone during the event. On occasion, the Joint Controllers may draw up minutes of the event, which will include a record of the contributions made to the event by name, but the Data Subject may indicate before speaking that he or she does not wish to be recorded by name. In such a case, this circumstance will be indicated by the Joint Controllers in the prospectus when the registration for the event is published.

3. Purpose of the processing and scope of the data processed

Ensuring the participation in the event organised by the Joint Controllers, prior registration of the applicant. Organising the event: planning the event's factors depending on the number of participants, providing the data subjects with relevant information about the event, meeting the specific needs of the data subjects, ensuring the communication of the event. Providing images and sound recordings to inform the public about the event and to inform the public about events in the district. Consent is retained for the purpose of verifying lawful processing. In the case of record keeping, the purpose of the processing of personal data is to ensure the traceability of the event.

4. Legal basis for processing

The legal basis for the processing of the data is the explicit voluntary consent of the data subject to the processing of his or her personal data, as referred to in Article 6(1)(a) of the General Data Protection Regulation.

The legal basis for the retention of the legal declarations relating to the privacy notice is the fulfilment of a legal obligation on the controller pursuant to Article 6(1)(c) of the GDPR, as referred to in Article 5(2) of the GDPR.

5. The source of the personal data processed , and the scope of the data not provided by the data subject to the Joint Controllers

The source of the personal data processed is the data subject. The Joint Controllers do not process personal data that are not collected from the data subject.

6. Recipients and categories of recipients of personal data In the case of images and audio recordings, the Joint Controllers shall publish the photographs and video

Controllers shall publish the photographs and video recordings that best match the atmosphere of the event and the purposes of the processing on the public website of the Municipality and on the Facebook and Instagram pages operated by Facebook Ireland Ltd. Joint Data Controllers will publish photos and videos of events of importance to the District in the District's newspapers and on television.

This process involves the use as data processors of the 100%-owned business entities involved in the event, as well as technicians acting on behalf of the Joint Controllers.

The municipality may occasionally forward the images and audio recordings to the municipality's wholly-owned business entities, so that these entities can also report on the event or event of district significance on their own media platforms (this will be indicated in the call for applications for the event).

In some cases, the Joint Data Controllers may decide to make the minutes public - in this case, this will also be indicated in the registration for the event.

7. Duration of processing

The Joint Data Controllers shall process the personal data of the data subjects until the settlement of the event at the latest, but at the latest until the limitation period for civil claims after the event has ended.

If minutes are kept, the minutes are kept for 15 years from the date of the event

Image and sound recordings The Joint Data Controllers shall select (delete data that are less likely to be used in the future and less likely to meet the purpose limitation principle), but

shall keep them for a maximum of 15 years, after a certain amount of data has been collected.

The data subject may withdraw his or her consent to the processing at any time during the period up to the deletion of the data at any of the contact details provided in point 1. The Joint Controllers shall erase the data subject's data within 10 working days of receipt of the request for withdrawal. The right to withdraw consent at any time shall not affect the lawfulness of the processing carried out on the basis of consent prior to its withdrawal. In the case of printed press products, the municipality will not be able to destroy the press product already produced even if consent to the publication of the image is withdrawn.

8. Allocation of rights to data processing, access to data Between Joint Controllers

In general, data processing will be carried out by the department of the Mayor's Office to which the event belongs according to its subject. The Mayor's Office is authorised to handle the exercise of the rights of data subjects, the handling of incidents, contacts with authorities and courts on behalf of the Joint Controllers. On a case-by-case basis, if the decision related to the event has to be taken by the Municipal Council of the Municipality of Józsefváros in the 8th district of Budapest, the Municipality is entitled to act on behalf of the Joint Controllers.

Data transfers to third countries - automated decisionmaking and profiling

The processing does not involve the transfer of personal data to third countries, automated decision making or profiling (posting on the website and social media platforms does not constitute data transfer).

10. Rights of the data subject in relation to data processing 10.1. Deadline

The Joint Controllers shall comply with the data subject's request to exercise his or her rights within a maximum of one month from the date of receipt of the request. The date of receipt of the request shall not count towards the time limit. The Joint Controllers may, if necessary, and taking into account the complexity of the request and the number of requests, extend this time limit by a further two months. The Joint Controllers shall inform the data subject of the extension of the time limit within one month of receipt of the request, stating the reasons for the delay.

10.2. Right of access

The data subject shall have the right to request the 1. to obtain from the Joint Controllers, through the contact details provided in point 1, information as to whether or not his or her personal data are being processed and, if such processing is taking place, the right to know which personal data are being processed by the Joint Controllers; on what legal basis;

for what purpose; for how long; to whom, when, under what law, to which personal data have been disclosed or transferred by the Joint Controllers; from what source your personal data originate; what rights you have in relation to the processing; whether your data are being profiled by the Joint Controllers or transferred to a third country.

The Joint Controllers shall provide a copy of the personal data subject to the processing free of charge for the first time upon the data subject's request, and may charge a reasonable fee based on administrative costs thereafter. In order to ensure data security and to protect the rights of the data subject, the Joint Controllers are obliged to verify the identity of the data subject and the identity of the person who wishes to exercise the right of access, and to this end, the provision of information, access to data and the issuing of copies of data are subject to the identification of the data subject.

10.3. The right to rectification

The data subject may request that the Joint Controllers modify any of his or her personal data through the contact details provided in point 1. If the data subject can credibly demonstrate the accuracy of the corrected data, the Joint Controllers shall comply with the request within a maximum of one month and shall notify the data subject thereof using the contact details provided by the data subject.

10.4. Right to restriction of processing

The data subject may request, through the contact details provided in point 1, that the processing of his or her personal data be restricted by the Joint Controllers (by clearly indicating the restriction of processing and ensuring that it is kept separate from other data) where.

- contests the accuracy of his or her personal data (in which case the Joint Controllers will limit the processing for the time necessary to verify the accuracy of the personal data);
- the data processing is unlawful and the data subject opposes the erasure of the data and requests instead the restriction of their use:
- the Joint Controllers no longer need the personal data for the purposes of processing, but the data subject requires them for the establishment, exercise or defence of legal claims.

10.5. The right to erasure

The data subject may exercise his or her right to erasure without restriction in relation to the processing described in the privacy notice, except for processing required by law. The data subject may withdraw his or her consent to the processing without time limitation, provided that the withdrawal of consent shall not affect the lawfulness of the processing prior to the withdrawal.

10.6. Right to legal redress

If the data subject considers that the Joint Controllers have infringed the applicable data protection requirements in the processing of his or her personal data, he or she may lodge a complaint with the National Authority for Data Protection and Freedom of Information (address: 1055 Budapest, Falk Miksa utca 9-11., postal address: 1363 Budapest, Pf. 9., Email: ugyfelszolgalat@naih.hu, website: www.naih.hu), or may take the matter to court, which will act out of turn, in order to protect his or her data. In this case, you are free to choose whether to bring your action before the competent court in your place of residence (permanent address) or domicile (temporary address) or the court of the place where the Joint Controllers have their headquarters. The Court of Budapest (Fővárosi Bíróság) has jurisdiction over the lawsuit according to the seat of the Joint Controllers.
